Report of the Study Group on North Pacific Ecosystem Status Report

The Study Group on the North Pacific Ecosystem Status Report (SG-NPESR3) met from 09:00 – 17:00 h, October 16, 2015, in Qingdao, China. The meeting was attended by seventeen members and guests, and it was chaired by Dr. Phillip R. Mundy. The list of participants and agenda are found in SG-NPESR3 Endnote 1 and SG-NPESR Endnote 2.

Accomplishments before and during PICES-2015

- A written report on progress of SG-NPESR was submitted at ISB-2015 (Dr. Elizabeth (Libby) Logerwell kindly presented the oral report at ISB-2015).
- Prior to PICES-2015, the SG developed an implementation plan for the third edition of NPESR (IP-NPESR) that resolved outstanding concerns of Standing Committees through a consultative process with them.
- At PICES-2015, the SG held a full-day editing session which included representatives from S-HD, WG 31 and the Secretariat that produced a consensus edition of the IP-NPESR. The session also produced a Powerpoint for briefing the Standing Committees, the expert groups, and Science Board at the Annual Meeting.
- A proposal was developed for an inter-sessional NPESR workshop in to be held in June 2016 which will
 review and evaluate candidate time series and progress on methods of production. The proposal presented
 to Science Board by the SG-NPESR3 Chair.
- During PICES-2015 the SG members made presentations on IP-NPESR to all Standing Committees, WG 31, WG 28, and the FUTURE Mini-Symposium. Members also talked individually with many of the PICES' meeting participants.
- Chair presented the Implementation Plan to Science Board at PICES-2015.

Request for addition to Study Group-NPESR3 Terms of Reference

• The Study Group will report to ISB-2016 on options for biogeographical classification of data submitted to NPESR-3, including a recommendation on a preferred approach.

Explanation: Feedback received during consultations with members of the Standing Committees and others indicated that having a means of organizing the individual data submissions into ecologically coherent regions would greatly aid the synthesis process.
